This Photo Booth Rental Agreement ("Agreement") is entered into between Halo Aura Media ("Company") and the Client identified below.

3. RESERVATION AND PAYMENT

3.1 Reservation Deposit

A deposit of One Hundred Dollars (\$100.00) is required at the time of booking to reserve the Event Date and Time.

The reservation is not confirmed until the deposit has been received by Halo Aura Media.

3.2 Final Payment

The remaining balance is due no later than three (3) calendar days before the Event Date.

Failure to make full payment by the due date may result in cancellation of the reservation and forfeiture of the deposit.

4. CANCELLATION AND RESCHEDULING

4.1 Cancellation by Client

(a) If the Client cancels six (6) or more calendar days before the Event Date, the deposit shall be refunded.

(b) If the Client cancels within five (5) calendar days of the Event Date, the deposit shall be forfeited.

4.2 Rescheduling

(a) Requests to reschedule are subject to Halo Aura Media availability.

(b) Rescheduling within five (5) calendar days of the Event Date shall require a Fifty Dollar (\$50.00) rescheduling fee.

(c) Any rescheduled event must occur within twelve (12) months of the original Event Date.

5. OVERTIME CHARGES

5.1 Additional Service Time

(a) Services requested beyond the scheduled End Time shall be billed at Seventy-Five Dollars (\$75.00) per thirty (30) minute increment or portion thereof.

(b) Halo Aura Media reserves the right to decline overtime requests due to scheduling, staffing, venue restrictions, or operational considerations.

6. PHOTO DELIVERY

6.1 Digital Media Delivery

(a) Digital photographs, videos, galleries, and event media will be delivered within three (3) calendar days following the Event Date.

(b) Delivery may be made through an online gallery, download link, email, text message, QR code, or other electronic means.

7. CUSTOM OVERLAY AND BORDER DESIGN

7.1 Design Proof

Halo Aura Media will provide a design proof for any package that includes a custom overlay, border, or template.

7.2 Included Revisions

The Client is entitled to two (2) revisions at no additional charge.

7.3 Revision Deadline

(a) All revision requests must be submitted no later than three (3) calendar days before the Event Date.

(b) Revision requests received after this deadline may be declined.

(c) The most recently approved design shall be used for the Event.

7.4 Client Approval

Halo Aura Media is not responsible for errors in names, dates, spelling, or event details approved by the Client.

8. EVENT SITE REQUIREMENTS

8.1 Client Responsibilities

The Client shall provide:

- (a) A safe and level setup area.
- (b) Adequate access to the event location.
- (c) Electrical power if required by the selected package.

9. ATTENDANT AND SAFETY POLICY

9.1 Attended Events

For events that include an attendant, guests shall comply with all instructions given by Halo Aura Media staff.

9.2 Unattended Events

For events without an attendant, the Client assumes responsibility for supervising use of the equipment.

9.3 Prohibited Conduct

The following activities are prohibited:

- (a) Climbing, sitting, standing, jumping, swinging, or hanging on equipment.
- (b) Moving, disconnecting, modifying, or tampering with equipment.
- (c) Operating equipment in an unsafe manner.
- (d) Any conduct that may cause injury or property damage.

9.4 Suspension of Services

Halo Aura Media may suspend or terminate services without refund if unsafe conditions exist.

10. DAMAGE TO EQUIPMENT

10.1 Client Liability

The Client shall be responsible for damage caused by guests, attendees, vendors, or any person under the Client's control.

10.2 Repair or Replacement Costs

The Client agrees to reimburse Halo Aura Media for repair or replacement costs resulting from negligence, misuse, vandalism, or theft.

11. WEATHER AND OUTDOOR EVENTS

11.1 Unsafe Conditions

Halo Aura Media may immediately suspend operations in the event of:

- (a) Rain.
- (b) Standing water.
- (c) Excessive wind.
- (d) Any condition that may create a safety hazard or damage equipment.

11.2 No Refund for Weather Interruptions

No refund shall be provided for interruptions caused by unsafe weather conditions.

12. PHOTO AND VIDEO RELEASE

12.1 Marketing Authorization

Unless the Client opts out by initialing here _____, the Client grants Halo Aura Media permission to use event photographs and videos for marketing and promotional purposes.

13. LIMITATION OF LIABILITY

13.1 Liability Cap

Halo Aura Media's liability shall not exceed the total amount paid by the Client under this Agreement.

14. GOVERNING LAW

14.1 California Law

This Agreement shall be governed by the laws of the State of California.

15. ENTIRE AGREEMENT

15.1 Entire Agreement

This Agreement constitutes the entire agreement between the parties and supersedes all prior discussions and understandings.

15.2 Amendments

Any modification to this Agreement must be in writing and signed by both parties.
